**Subject: Approval of Rio Grande Valley Thoroughfare Plan Amendments**

Honorable Judge Cortez, Commissioner Fuentes, Commissioner Cantu, Commissioner Villarreal, Commissioner Torres,

The Rio Grande Valley Metropolitan Planning Organization (RGVMPO) has completed the annual process of accepting amendments to the Rio Grande Valley Thoroughfare Plan from all partner Cities and Counties across the region. The RGVMPO Transportation Policy Board has approved for proceeding with the requisition for approval of Amendments to the Rio Grande Valley Thoroughfare Plan by the Hidalgo County Commissioner's Court.

Amendments to the Rio Grande Valley Thoroughfare Plan are as follows:

Hidalgo County PCT 1

- Mile 1 ½ West From: Mile 12 North To: Levee Road as an Expansion Collector 80'
- Mile 21 ½ North From: FM 88 To: FM 491 as an Expansion Collector 80'
- Uncle Peters Road From: First Street in La Villa / Mile 17 North To: Jaritas Road / CR 3301 as an Expansion Collector 80'

Hidalgo County PCT 4

- De la Rosa Street From: Alamo Road To: Brushline Road removal from Thoroughfare Plan.
- Terry Road From: FM 88 To: FM 491 removal from Thoroughfare Plan.

The RGVMPO accepts updates to the Rio Grande Valley Thoroughfare Plan annually. In August 2021, the RGVMPO will meet with all member governmental entities to request amendments to the Rio Grande Valley Thoroughfare Plan. If changes are required, the approval of the Hidalgo County Commissioner's Court will be requested in April of 2022.
