The Health and Human Services Commission (HHSC) and County of Hidalgo Community Service Agency (Grantee), collectively the Parties to that certain Grant Contract which provides funding for administration and operation of the Grantee's Senior Corps Program and associated services (collectively, the "Services") effective September 1, 2020 and denominated HHSC Contract No. HHS000871100030, now want to amend the Contract.

WHEREAS, the Parties want to add funds to the Contract as a one-time payment for Fiscal Year 2021 Services.

The Parties therefore agree as follows:

1. Section IV of the Contract, Funding, is hereby amended by adding \$316.48, to the Contract, resulting in a total not to exceed Contract amount of \$5,792.48.
2. This Amendment shall be effective upon the last date of signature.
3. Except as amended by this Amendment, all terms and conditions of the Contract shall remain in effect.
4. Any further revisions to the Contract shall be by written agreement of the Parties.
