Hidalgo County was awarded a Moody Foundation Grant (#2020-172 \$250,000) last year. We have implemented some great programs to assist first responders throughout the COVID-19 pandemic response thanks to the Moody Foundation grant we received.

We recently identified some needs and are requesting authorization from Moody foundation to allocate some funding from the grant to the following:

- Authorization to provide meals and other necessities to the health department, Texas Military Department, First Responders and Emergency Management Department.

-Authorization to obtain drones and equipment to help protect our first responders for emergency responses during the COVID-19 pandemic.
