Narrative

On Tuesday March 16, 2021 at around 10:00 am Hidalgo County Deputy Luis Carrillo # 4821 was dispatched east of 1.5 west on Mile 11 to sunset Park numerics: 5230 Mile 11 in Mercedes, Hidalgo County, Texas in reference to a Theft.

Upon arrival made contact with Guadalupe Rangel Jr. DOB: [REDACTED] who said:

- He works for Precinct 1 office.
- About a week ago he noticed he was missing a 2003 white in color F-150 truck from the precinct office yard. 41266
- The truck is parked on the north side of the property with other vehicles.
- The vehicles are left at the yard before they are auctioned.
- He did not call the sheriff office until he verified the truck was missing.
- He estimates the truck to be valued at about \$2169.00.
- The truck was last seen on the yard the last days of December 2020.
- He has no idea who could have stolen the truck.
- The keys are kept at Hidalgo County Purchasing office in the city of Edinburg, Texas.
- He wants file a report.
- He called the Sheriff Office.
- He wants to file charges in behalf of the precinct office.

Deputy's actions and observations:

- Arrived at location.
- Made contact with reporting party and obtained information.
- Learned there is only two entrances to the yard.
- Learned there is a security officer who works from 6:00 pm to 6:00 am.
- The security company is called M16 protection Security and the owners name is Armando (956)227 9039.
- Reporting party does not know the name of the security officer who has been working on shift.
- Obtained Texas license plates 860 678.
- Ran inquiry check on truck which came back clear.
- Obtained NIC: V292783083 number.
- Obtained case number.
- No further actions taken.
