Narrative

On Wednesday April 7, 2021, at 10:45 AM, I Hidalgo County Sheriff's Deputy Alvin Lofton #5337 was dispatched east of Mile 1.5 West on Mile 11 Road, to the Precinct 1 Office, address of 13226 Mile 1.5 West Road, Mercedes, Hidalgo, County Texas in reference to a Theft Report.

Met with Guadalupe Rangel JR, [REDACTED], who stated:

- He takes care of asset accountability for Hidalgo County Precinct #1.
 - He has been working for Precinct #1 since 2017.
 - This past March 31, of 2021 they had an auction for all their surplus vehicles and equipment.
 - He noticed that a 2001 Ford F-150 white in color with Texas license plates 45818 802-339 and VIN# 1FTRX18L71NB01001 registered to the Hidalgo County Precinct #1's office was not in the auction yard.
 - He also noticed a 1998 Big-Tex flat bed trailer black in color with Texas license plates 985-491 and Serial # 4K8NX1623WIC27523 was not at the auction yard either. 32072
 - The truck is valued at \$2,300.00 and the trailer is valued at \$1,100.00 a total of \$3,400.00.
 - The last time they were accounted for was before December of, 2020.
 - He thinks it must of happened between December of 2020, and March 31st of 2021.
 - He does not know who could have taken the truck and the trailer.
 - There is no camera's in the area to play back and see who took them.
 - There was supposed to be security at location during the time frame they possible took them.
 - He has not had time to contact the security company and question the security guards working at the time.
 - He wants to file charges on behave of Hidalgo County Precinct #1 if they are able to find who took the trailer and truck.
- Deputy's actions/observations: I
- Arrived at location.
 - Made contact with Guadalupe and obtained his information.
 - Obtained Information of stolen vehicle and trailer from Guadalupe.
 - Ran a records check on the vehicle and trailer with the information provided by Guadalupe and they came back clear.
 - Observed Guadalupe was not able to provide any information regarding possible suspect(s)
 - Advised Guadalupe the incident would be documented and the vehicle and trailer entered as stolen in the NCIC/TCIC system.
 - Provided Guadalupe a business card and case number.
 - Contacted communication via telephone and made contact with communications officer Acevedo #5540.
 - Acevedo entered the truck as stolen and provided NIC# V762831591 and NIC# V692815610 for the trailer.
 - Took no further actions.
 - Resumed normal patrol duties.
