On Wednesday October 2, 2019 at 7:35 am, I, Jesus Constantino C-7 responded to a shed belonging to Hidalgo County Precinct 1 located at 1902 Joe Stephens drive in the City of Weslaco, Hidalgo county,, Texas in reference to a burglary of a building.

Upon arrival, I made contact with a county employee Identified as Ricardo Gregorio Moreno DOB 06-02-63 who said that this morning at about 7:15 am he arrived to the Precinct 1 shed to open up and he noticed that the east side entrance door was damaged he then went inside and also noticed in the office that the AC unit was off the wall and on the floor. He then said he continued to look around inside the shed and noticed that the west side door was open, he then walked towards the open door and noticed that a red in color with a black frame Honda Generator was missing from a utility trailer parked inside the shed. Ricardo said the generator is worth about \$3,500.00. he then went outside again to check if anything else was missing and he noticed the lock on the gate on the north side was broken. Ricardo then went back inside to check if anything other than the Generator was missing and he noticed small crowbar was left behind on the trailer. The crow bar appears to have been used to pri open the east side door and also to break the lock on the gate, the crowbar was collected and will be submitted into evidence. Ricardo said that the last time the generator was seen was 10-01-19 at about 3:45 pm, Ricardo is wishing to file charges on behalf of the Hidalgo County Precinct 1.
