**FIRST AMENDMENT TO
FACILITY USE AGREEMENT BETWEEN THE AMERICAN RED CROSS AND THE
COUNTY OF HIDALGO**

THIS FIRST AMENDMENT TO FACILITY USE AGREEMENT (“Agreement”) is made and entered the _____ day of _____, 2021 by and between HIDALGO COUNTY, TEXAS, (“County”) and THE AMERICAN RED CROSS (“Red Cross”).

WITNESSETH:

WHEREAS, Red Cross is a non-profit corporation chartered by the United States Congress to provide services to individuals, families and communities when disasters strike; and

WHEREAS, County is: a local government of the State of Texas; and

WHEREAS, Red Cross and County have a common goal to promote the health, safety and well-being of the citizens of the County of Hidalgo; and

WHEREAS, on or about the 15th day of January, 2019, the Red Cross and County entered into an agreement (“Agreement”) to permit the Red Cross upon its request to utilize specifically listed County facilities to provide services during a disaster; and

WHEREAS, County and Red Cross now desire to amend the Agreement to change the number of County locations which may be utilized by the Red Cross to provide services during a disaster.

WHEREAS, the updated Facility List wherein the Red Cross may provide disaster services pursuant to the Facility Use Agreement is attached as **Exhibit A**;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Red Cross hereby agree to the following amendment to the Agreement.

1. The Facility List provided with the Initial Agreement between the parties is removed and replaced with the Amended Facility List attached as **Exhibit A** and incorporated herein for all purposes. The American Red Cross may provide services during a disaster at the locations provided in amended Facility List.
2. Except as modified herein, all terms and conditions of the Agreement, remain in full force and effect. County and University ratify and confirm the terms and provisions of the Agreement as amended herein.
