
S&B Infrastructure, Ltd. has reviewed the bid information provided by all bidders for the City of La Villa – 2020 Street Improvements and has compiled the attached bid tabulations.

Based on the bid tabulations, and the analysis completed by S&B, the actual low bidder for the City of La Villa – 2020 Street Improvements is GNH Company., with a low bid of \$99,051.00 which is 43% below the Engineer's Estimate of \$177,582.90. We have attached the Bid Analysis for all six bidders with respect to the engineers estimate for your reference. (See Attachment 1).

We have reviewed the bid forms, bid bond, and other required bid documents as shown in the attached Bid Award Checklist. S&B has some concerns related to the low bid being significantly under the Engineer's Estimate, however due to the multiple bids below and the varied unit prices within a similar range these concerns were resolved. Based on our Bid Analysis and the fact that the low bidder has all its proper documents, it is our recommendation to award the contract to **GNH Company, LLC.**

**CONSTRUCTION
CONTRACT**

This Agreement entered into this June 15, 2021 by and between Hidalgo County acting by and through Hidalgo County Urban County Program, hereinafter called the "OWNER", acting herein through its County Judge and GNH Company LLC (a corporation) (a partnership) (an individual) of Alamo, State of Texas, hereinafter called "CONTRACTOR".

WITNESSETH

That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the OWNER, the CONTRACTOR hereby agrees with the OWNER to commence and complete the construction described as follows:

PROJECT NAME: 2020 La Villa Street Improvements

PROJECT DESCRIPTION: Street Improvements

hereinafter called the project, for the sum of (\$99,051.00.) – ninety nine thousand fifty one dollars and zero cents and all extra work in connection therewith, under the terms as stated in the General and Special Conditions of the Contract; and at his (its or their) own proper cost and expense to furnish all the materials, supplies, machinery, equipment, tools, superintendence, labor, insurance, and other accessories and services necessary to complete the said project in accordance with the conditions and prices stated in the Proposal, the General Conditions, Supplemental General Conditions and Special Conditions of the contract, the plans, which include all maps, plats, blue prints, and other drawings and printed or written explanatory matter thereof, the specifications and contract documents therefore as prepared by S&B Infrastructure and as enumerated in Paragraph 1 of the Supplemental General Conditions, all of which are made a part hereof and collectively evidence and constitute the contract.

The CONTRACTOR hereby agrees to commence work under this contract on or after a date to be specified in a written "Notice to Proceed" of the OWNER and to fully complete the project within (60) sixty consecutive calendar days thereafter. The CONTRACTOR further agrees to pay, as liquidated damages, the sum of (\$500.00) Five hundred dollars and zero cents for each consecutive calendar day thereafter as hereinafter provided in Paragraph 19 of the General Conditions.

The OWNER agrees to pay the CONTRACTOR in current funds for the performance of the contract, subject to additions and deductions, as provided in the General Conditions of the contract, and to make payments on account thereof as provided in Paragraph 25, "Payments to Contractor", of the General Conditions.
