SUPPLEMENTAL AGREEMENT NO. 1
To Work Authorization No. 1
of AGREEMENT FOR PROFESSIONAL SERVICES
(C-18-075-02-27)

This **SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and **B2Z Engineering, LLC**, Professional Engineers of Mission, Texas, hereinafter called “**Engineer**”.

WITNESSETH

WHEREAS, the **Owner** and the **Engineer** executed the **Agreement** on the 27th day of February, 2018 concerning engineering for PS&E, Design Surveying, Traffic Signal Design, Pavement Design, Right-of-Way Mapping, and Comp. & Permitted Utility Coordination for Las Milpas Road (hereinafter referred to as the “**Project**”); and,

WHEREAS, Article 8 of the **Agreement**, (Supplemental Agreements), establishes that the terms of this Agreement may be amended by supplemental agreement if the Owner determines that (3) for any other reason agreeable to the Owner and the Engineer; and,

WHEREAS, it has become necessary to amend the contract to revise the current plan set to reflect the latest project responsibilities.

WHEREAS, it has become necessary to amend “Exhibit D- Fee Proposal” of Work Authorization No. 1 to increase the original amount of **\$403,420.47** to **\$428,472.22**; therefore, the amount of **Supplemental No.1** is **\$25,051.75**.

A. AGREEMENT

NOW THEREFORE, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:

- I. Section of the Agreement, “Exhibit D – Fee Proposal”, is revised to reflect the above listed modification of this Supplemental.

All other provisions are unchanged and remain in full force and effect.
