The County's Contract for Services C-21-043 with Big D Tractor Co. is approved as to form.

The Master Equipment Rental Agreement provided by Big D Tractor Co. is approved as to form subject to the following recommended modifications:

- On p. 2, remove No. 4, (b),(c) & (d) and replace with the following language:  
"b. You agree to pay Big D Rent for each Rented Item payable against written invoice submitted by Big D; as well as any delivery/shipping charges, fuel, cleaning, repairs, Pro Rata Maintenance Charges, etc. which Big D may, at its option, invoice separately, in accordance with the payment provisions of the Texas Prompt Payment Act, Tex. Govt. Code Ch. 2251."
- On p. 4-5, No. 19 - recommend verifying if the County meets the insurance amounts as requested by the vendor. If not, then recommend removing the language in No. 19 and replacing it with the following:  
"The County will carry sufficient general liability and property insurance at the statutorily required limits, pursuant to the Texas Tort Claims Act, and workers compensation insurance in amounts established by Texas law."
- On p. 7, No. 31 and bottom of p. 8 - remove language regarding County waiving its rights under the Deceptive Trade Practices-Consumer Protection Act.
- On p.7 and p.8, signature section - do not include the requested County's authorized signer's driver's license or ID No.
