

**HEALTH AND HUMAN SERVICES COMMISSION
CONTRACT NO. HHS000871100030
AMENDMENT NO. 2**

The Health and Human Services Commission (HHSC) and County of Hidalgo Community Service Agency, collectively the Parties to that certain Grant Contract which provides funding for administration and operation of the Grantee's Senior Corps Program and associated services (collectively, the "Services") effective September 1, 2020, and denominated HHSC Contract No. HHS000871100030, now want to amend the Contract.

WHEREAS, the Parties desire to delete and replace Section IV, Funding, of the Contract; and

WHEREAS, the Parties desire to add funds to the Contract to pay for Services delivered during FY2022 and FY2023.

NOW, therefore, the Parties agree as follows:

1. Section IV, Funding, of the Contract is deleted and replaced with the following:
The total amount of this Contract is not to exceed the **TOTAL CONTRACT AMOUNT \$17,377.44**. The funding for each fiscal year (FY) is not to exceed the following amounts:
 - a. FY 2021 – \$5,792.48 for September 1, 2020 through August 31, 2021;
 - b. FY 2022 – \$5,792.48 for September 1, 2021 through August 31, 2022;
 - c. FY 2023 – \$5,792.48 for September 1, 2022 through August 31, 2023.

The total Contract amount, including the FY2022 and FY2023 funding allocation, is subject to increases or decreases as funds may be appropriated throughout the contractual term based on actions of the federal government, the Texas Legislature, or both. Throughout the contractual term, Grantee will be notified of the availability of funding through a Notice of Funds Available (NFA) document. Any further revisions to this Contract, including the budget amounts, may only be amended by a written amendment executed by both Parties.

2. This Amendment shall be effective upon the last date of signature.
3. Except as amended by this Amendment, all terms and conditions of the Contract, as amended, shall remain in effect.
4. Any further revisions to the Contract shall be by written agreement of the Parties.
