A query was done on the state 9-1-1 database and found no conflict for the proposed name to be used.

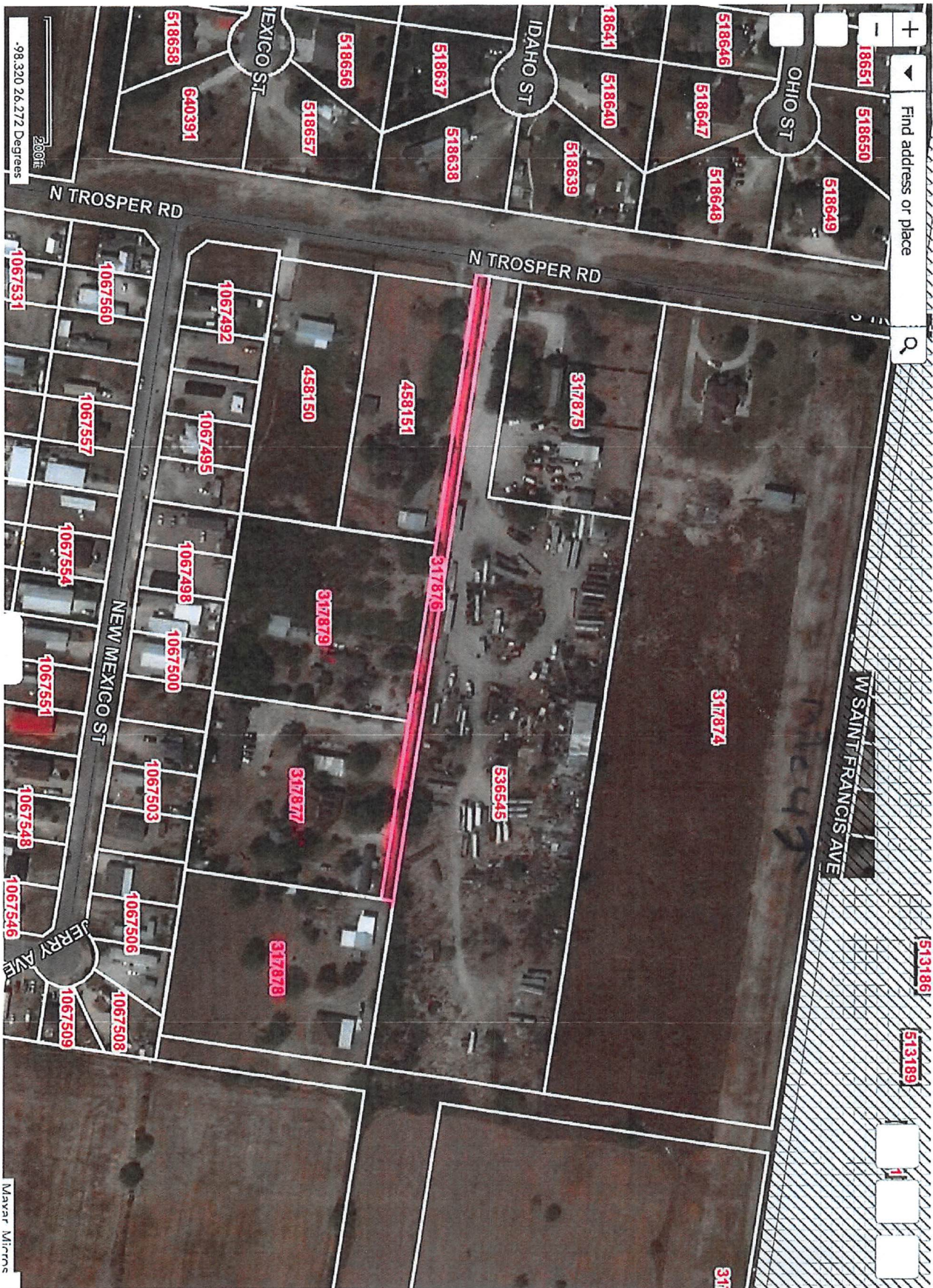
