Thank you again for assisting us with our Deputy Contract agreements. General Manager Roberto Lucio has requested that Boggus Motor Sales II, LLC DBA Boggus Ford GDN Number P118702 and DBA Boggus Ford Pre-Owned GDN number P150601 be part of the WebDealer Deputy program. Dealer desires to act as agents of the County in the issuance of motor vehicle license registration stickers, license plates and in the application for vehicle titles. Each dealership will obtain a bond in the amount of \$100,000 as determined by the County Tax Assessor-Collector.

At this time we would like to formally request legal approval to proceed with this request from our Commissioners. I am forwarding you a copy of the dealer deputy agreement and supporting documents.

Discussion and approval to execute a dealer deputy agreement between the County of Hidalgo and Boggus Motor Sales II, LLC DBA Boggus Ford GDN Number P118702 and DBA Boggus Ford Pre-Owned GDN Number P150601. Dealer desires to act as an agent of the Tax Assessor Collector in the issuance of motor vehicle registration stickers, license plates and in the application for vehicle titles. This agreement is subject to the Dealer Deputy providing a surety bond in an amount as determined by the County Tax Assessor-Collector in accordance with applicable law.

Background

Boggus Motor Sales II, LLC applied to be an authorized Dealer Deputy for Hidalgo County. Boggus Motor Sales II, LLC agreed to comply with the requirements of the Texas Department of Motor Vehicles WebDealer system. The Dealer Deputy will furnish and maintain any necessary equipment. Transportation Code Sec 520.0071 DEPUTIES states a county assessor-collector, with the approval of the commissioners court of the county, may deputize an individual or business entity to perform titling and registration services in accordance with rules prescribed and adopted in the Texas Administrative Code Title 43 Part 10 Chapter 217 Subchapter H.
