The Professional Engineering Services Agreement C-21-0601-09-21 is approved as to form subject to adding the following language in blue to No. 2 of the agreement:

2. **Scope of services to be provided by the Owner are detailed in the attached Exhibit "B".** The County will furnish Specifications to Engineer for the development of the project(s) and fulfillment of this Agreement. Engineer agrees to review the project as presented by County and submit to County within fourteen (14) days of receipt of the Specifications, a proposal, and work authorization. The proposal shall include, but not be limited to, the following: (1) fee structure for the project; (2) services included in the basic fee; (3) amount of, or basis for, compensation for additional services (including additional services that may arise during the course of the project and cost of Engineer's consultants); and (4) cost for reimbursable expenses (collectively the "Engineering Services Proposal");
