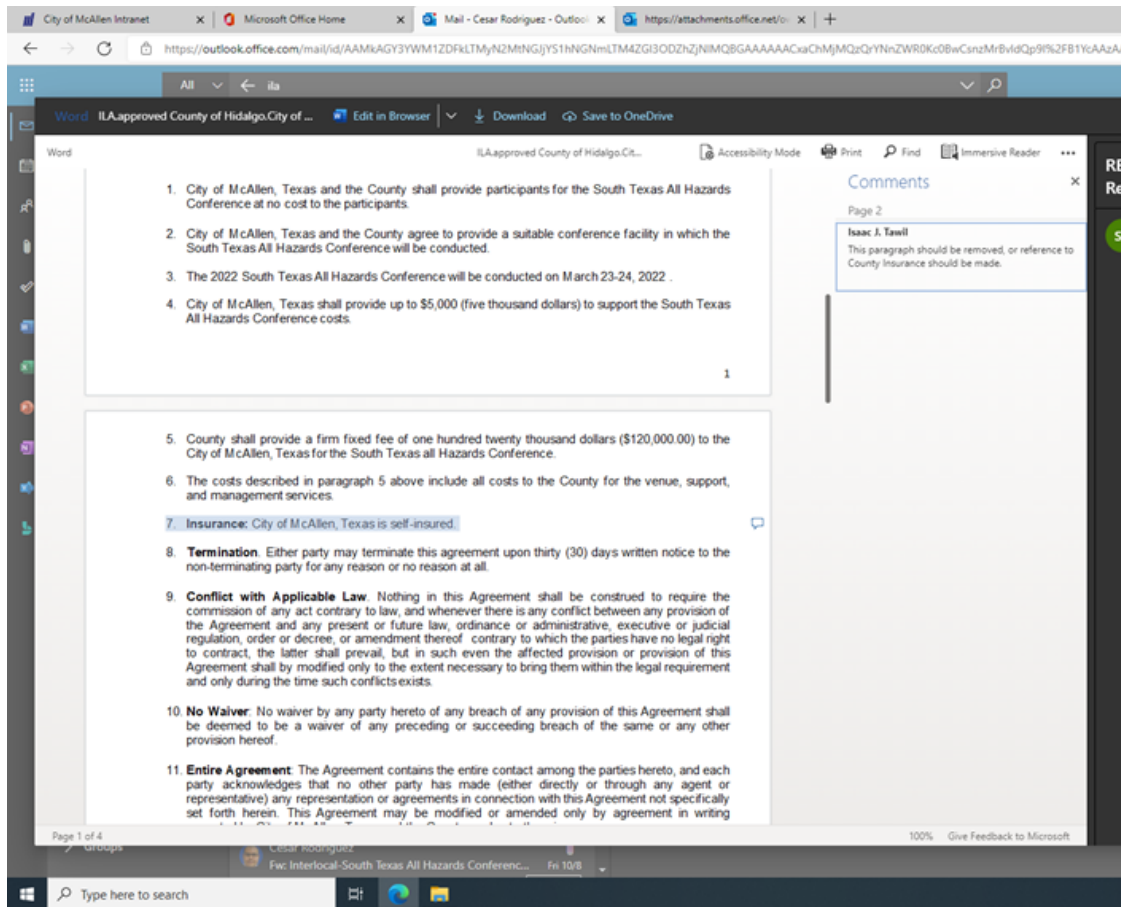
The revision requested by Mcallen legal counsel is on LINE 7.
