1	Election Precinct 4	Reduce voter size by removing territory east of 2557 into NEW Election Precinct 214
2	Election Precinct 156	Reduce voter size by removing territory east of 2557 into NEW Election Precinct 214
3	Election Precinct 36	Create NEW Election Precinct 208 along N. Ebony St. to E. Lucas St. to N. Ironwood St. for Congressional, House, and Commissioner lines
4	Election Precinct 36	Create NEW Election Precinct 258 along N.Cypress to E. Juarez Ave to N. Dogwood St for House and Commissioner lines
5	Election Precinct 43	Create NEW Election Precinct 259 along Alamo Rd. and Wisconsin Rd for Commissioner and Justice Precinct lines
6	Election Precinct 43*	Split along Alamo Rd on the west and E. Curve Rd on the south to create NEW Election Precinct 260 to reduce voter size
7	Election Precinct 189	Move territory south of Wisconsin Rd into Precinct 44 for Commissioner and Justice Precinct lines
8	Election Precinct 44	Gain territory north of Wisconsin Rd from Election Precinct 189 for Commissioner and Justice Precinct lines
9	Election Precinct 53	Move southern portion along Freddy Gonzalez Dr to S. Raul Longoria Rd to E. Sprague St to create NEW Election Precinct 261 to reduce voter size; gains territory in the northeast portion near S. Doolittle Rd, E. Curve Road, E. Hwy 107 and S. Cesar Chavez Rd into Precinct 158 to reduce voter size
10	Election Precinct 158	Loses territory in the northern portion along E. Curve Rd to Precinct 53 to reduce voter size
11	Election Precinct 62	Lose territory in the northeast portion bounded by E. Violet Ave, N Col Rowe Blvd, E. Dove Ave, and S. McColl St. into NEW Precinct 262 for Congressional Lines
12	Election Precinct 81	Remove territory west along N. Ware Rd into Precinct 84 and remove additional territory south along W. Dove Ave into Precinct 65 to reduce voter size
13	Election Precinct 84	Gains territory east of N. Bentsen Rd from Election Precinct 81 to add voters

14	Election Precinct 65	Gains territory north of 1924 to N. Ware Rd from Election Precinct 81 to add voters
15	Election Precinct 87**	Remove territory south along E. Roosevelt Rd into NEW Election Precinct 263 to reduce voter size (note exception areas for the City of Donna)
16	Election Precinct 88	Remove territory west along S. Conway Ave into Precinct 183 to reduce voter size
17	Election Precinct 183	Gains territory north of W. Mile Rd and to N. Conway Ave from Election Precinct 88 to add voters
18	Election Precinct 99	Remove territory north along W. Mile 5 Rd into Precinct 254
19	Election Precinct 254	Remove original territory along W. Mile 6 Rd, N. Brushline Rd, W. Mile 7 and N. Doffing Rd for SBOE Lines to Election Precinct 64; gains territory from Election Precinct 99 from W. Mile 5 Rd to N. Moorefield Rd to W. Mile 7 Rd.
20	Election Precinct 64	Add territory in the northeast corner from Election Precinct 254 along W. Mile 6 Rd, N. Brushline Rd, W. Mile 7 and N. Doffing Rd for SBOE Lines
21	Election Precinct 209	Combined with Precinct 256 keeping Election Precinct number 209
22	Election Precinct 236	Remove territory east along Shary Rd to Election Precinct 83 for House lines
23	Election Precinct 83	Gains territory north of E. Mile 2 Rd from Election Precinct 236 for House lines
24	Election Precinct 101	Remove territory in the eastern portion along Shary Rd to re-established Election Precinct 256 for House lines
25	Election Precinct 256	Re-established election precinct gains territory east of 494 from Election Precinct 101 for House lines
26	Election Precinct 106	Loses territory in northeast portion following W. Wisconsin Rd, S. Jackson Rd, and W. Canton Rd to Precinct 52 to reduce voter size

27	Election Precinct 52	Gain territory west of N. Sugar Road following W. Wisconsin Rd, S. Jackson Rd, and W. Canton Rd from Election Precinct 106 to add voters
28	Election Precinct 52	Loses territory north of W. Canton Rd to Election Precinct 151 to reduce voter size
29	Election Precinct 152	Combined with Election Precinct 151; keeping Election Precinct number 152
30	Election Precinct 151	Re-establish Election Precinct 151 by adding territory from Election Precinct 106 and Election Precinct 52 along S. McColl St, W. Freddy Gonzalez Dr., S. Closner Blvd. and W. Canton Rd.
31	Election Precinct 115	Remove territory in southeast portion along N. Ironwood St., E. Chapa St, N. Huisache St., E. Polk Ave., N. Juniper Ave, and North Frontage Road of US 83 West into NEW Election Precinct 264 for Congressional lines
32	Election Precinct 117	Remove territory in the northern portion along W. Eldora Rd into Election Precinct 228 (re-established this number) to reduce voter size (we originally assigned this area to NEW 265)
33	Election Precinct 212	Reconfigure Election Precinct 212 to follow N. Shary Rd for Commissioner Precinct lines (we originally assigned it to a NEW 266 but reconfigured both 212 and 211 to save building a new election precinct.
34	Election Precinct 211	Reconfigure Election Precinct 211 to follow N. Shary Rd for Commissioner Precinct lines; (originally assigned NEW 266 and then realigned to re-use Election Precinct number 211)
35	Election Precinct 228	Lose all of this territory into Election Precincts 20 and 226; Re-establish Precinct 228 as a split portion of 117
36	Election Precinct 20	Gains territory from the western portion Election Precinct 228 along S. McColl Rd
37	Election Precinct 226	Gains territory from the eastern portion Election Precinct 228 along S. McColl Rd
38	Election Precinct 134*	Combined with Election Precinct 168; keeping Election Precinct number 134
	Election Precinct 264	Renumber Election Precinct 264 to re-established Election Precinct 168
40	Election Precinct 168	Original territory combined with Election Precinct 134; re-established election precinct number for territory in Election Precinct 264; Territory remains the same but the renumbering takes effect.

43	Election Precinct 262	Re-establish Election Precinct number 162 for territory in Election Precinct 262; Territory remains the same but the renumbering takes effect.
44	Election Precinct 263	Re-establish Election Precinct number 163 for territory in Election Precinct 263; Territory remains the same but the renumbering takes effect.
47	Election Precinct 260	Re-establish Election Precinct number 142 for territory in Election Precinct 260; Territory remains the same but the renumbering takes effect.
48	Election Precinct 261	Re-establish Election Precinct number 143 for territory in Election Precinct 261; Territory remains the same but the renumbering takes effect.
45	Election Precinct 142	Entire territory moved into Election Precinct 60; re-establish this election precinct number for Election Precinct 260
