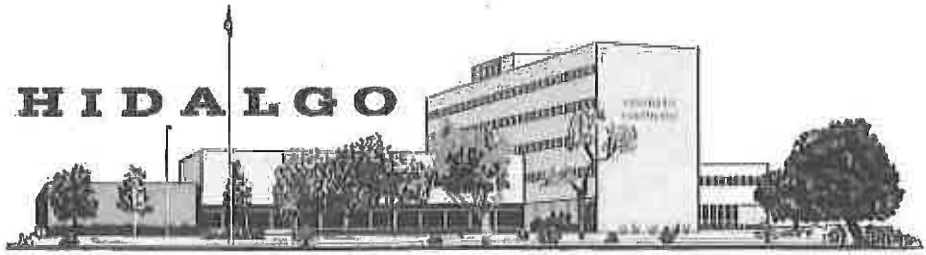

Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for December 14, 2021. Our review consisted of selected agenda items. Based on our review, the following observations were made:

**Consent Agenda Item 13.F. (AI-83696) – Purchasing Department**

The current ACORD Certificate of General Liability Insurance for CC Distribution, Inc. is not attached. We recommend that the current ACORD Certificate be attached prior to Commissioners Court approval.

**Consent Agenda Item 13.G. (AI-83758) – Purchasing Department for Constable Pct. 1**

The purchase of vehicle equipment and supplies is not allowable under the OPSG grant. We recommend that the grantor's approval be obtained prior to Commissioners Court approval.

**Consent Agenda Item 13.K. (AI-83646) – Purchasing Department for Health & Human Services**

Not all of the listed items are on the approved budget template for the COVID-19 Health Disparities grant. We recommend that the budget template be revised and approved by the grantor prior to Commissioners Court approval.

**Regular Agenda Item 6.B. (AI-83718) – Precinct 3**

The Permits are incomplete (i.e., contain blanks) and legal counsel's review and approval of the Permits is not attached. In addition, documentation (e.g., agreement, MOU, invoices) for the payment amounts listed on the agenda caption is not attached. We recommend that the complete Permits, legal approval, and payment documentation be attached prior to Commissioners Court approval.

**Regular Agenda Item 16.D. (AI-83594) – Human Resources**

Pursuant to the Fiscal Note, funding for the full-time temporary positions is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

**Regular Agenda Item 19.A.1 (AI-83481) – Health Care Funding District**

The certification of revenues and appropriation for the IGT are pending receipt of instructions from HHSC.

The documents for the donation of Parcel 1 Parts 1 through 4 and legal counsel's review and approval of the documents are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 27.C. (AI-83734) – Budget & Management

The transfers are not attached. We recommend that the transfers be attached prior to Commissioners Court approval.

Regular Agenda Item 27.G. (AI-83831) – Budget & Management

The MOU with Med-Care EMS and legal counsel's review and approval of the MOU are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 28.B.1. (AI-83829) – Purchasing Department for Executive Office

Change Order No. 1 and the Certificate of Interested Parties (Form 1295) are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 28.B.2. (AI-83821) – Purchasing Department for Executive Office

Supplemental Agreement No.1, legal counsel's review and approval of the Supplemental Agreement, and the Certificate of Interested Parties (Form 1295) are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 28.G.1. (AI-83662) – Purchasing Department for Health & Human Services Dept.

The funding source is not disclosed in the Fiscal Impact section. In addition, the monthly fee is \$4,986.81 plus applicable taxes. Also, the Certificate of Interested Parties (Form 1295) is not attached. We recommend that the funding source be disclosed in the Fiscal Impact Section; the monthly fee be clarified for the record; and Form 1295 be attached prior to Commissioners Court approval.

Regular Agenda Item 28.G.2. (AI-83668) – Purchasing Department for Health & Human Services Dept.

The quote is for the period of 09/01/2021 – 07/31/2023; however the grant period end on 05/31/2023 (unless extended). We recommend that alternate funding be identified for the period beyond the termination of the grant.
