**ORDER VACATING AND DISCONTINUING COUNTY ROAD  
AND CONVEYING HIDALGO COUNTY'S INTEREST TO THE CITY OF WESLACO**

**WHEREAS**, the Commissioners Court of Hidalgo County, on the 30th day of November 2021, at a duly called and noticed meeting of the Hidalgo County Commissioners Court at which a quorum was present came to be heard facts and information concerning the City of Weslaco's (City) proposal to Annex South Border Avenue from Mile 5 North to Tierra Santa Boulevard, a county road is 0.86 acres of land (the "Road") and the entire width of the Road and the adjacent right-of-way on both sides of the Road, more particularly described by metes and bounds as attached hereto as Exhibit "A" and made part hereof.

**WHEREAS**, Hidalgo County, Texas and the City of Weslaco currently each own half of the Road in Exhibit "A"; and

**WHEREAS**, Hidalgo County desires to vacate and discontinue the maintenance of the Road and requests that City maintain the Road in accordance with Subchapter B, Section 251.051 of the Texas Transportation Code; and

**WHEREAS**, the governing body of the City desires to take full responsibility in maintaining the Road located in the City of Weslaco to promote and protect the general health, safety, and welfare of persons residing in and adjacent to the City;

**WHEREAS**, the City may by ordinance annex a road right-of-way on request of the County that maintains the road and applicable right-of way under the procedures prescribed by the Texas Local Government Code; and

**WHEREAS**, the City has provided County written notice of the proposed annexation, in accordance with the requirements set forth in the Texas Local Government Code (see Exhibit A); and

**WHEREAS**, County and City acknowledge that Road shall continue to be used as a public road.

**NOW, THEREFORE, BE IT ORDERED, ADJUDGED AND DECREED** that the Commissioners Court of Hidalgo County based on the facts presented, does hereby unanimously agree to vacate, discontinue and convey its interest in the Road as described in Exhibit "A" to the City of Weslaco.

**BE IT FURTHER ORDERED** that, a copy of this Order shall be filed in the deed records of Hidalgo County and serves as the official instrument of conveyance from Hidalgo County to the City of Weslaco.

**WHEREUPON,** Commissioners Court moved for the adoption of said Order, said Motion being seconded by and duly adopted by all members of the court present voting "aye".
