**FIRST AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT
BETWEEN THE COUNTY OF HIDALGO, TEXAS, AND THE CITY OF
ALAMO, TEXAS**

This Amendment to the Interlocal Agreement is made and entered into this 15th day of June, 2021, by and between **COUNTY OF HIDALGO, TEXAS**, by and through its Precinct 1, hereinafter referred to as ("County"), and **CITY OF ALAMO** hereinafter referred to as ("City"), collectively referred to as "Parties" and pursuant to the provisions of the Texas Interlocal Cooperation Act ("Act"), Chapter 791, et seq., Texas Government Code, as follows:

WITNESSETH:

WHEREAS, in order to serve a public purpose and provide a mutual benefit to each other the County and the City entered into an Interlocal Agreement dated October 20, 2020, wherein the Parties agreed to jointly undertake a road reconstruction improvement project to a portion of Crockett Ave. (From Tower Rd. to Border Rd.) in Hidalgo County, Texas (the "Road" or "Project"); and

WHEREAS, the Agreement indicates that the Project will be completed no later than 240 days from the execution of the initial Agreement.

WHEREAS, the Parties have commenced the Project; however, due to unforeseen circumstances, it has become necessary to extend the deadline to complete the Project as outlined in the Agreement;

NOW THEREFORE, THE PARTIES in consideration of the terms and provisions set forth herein, agree to the following Amendment to the Agreement:


1. Numbered Paragraph 7 shall be deleted in its entirety and the following shall be substituted in lieu thereof:
 7. "County and City will coordinate work schedules in order to provide for minimal disruption to the public and to the operational fiscal affairs of the parties and will complete the Project no later than 240 days from April 19, 2021."
2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and CITY and COUNTY ratify and confirm the terms and provisions of the Agreement, as amended.

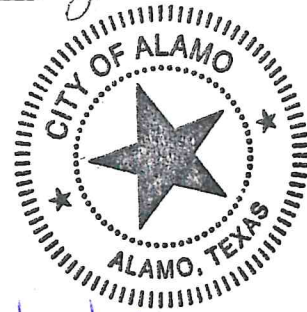




