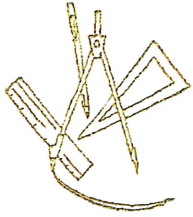


- **RGVMPO POLICY BOARD MEETING**

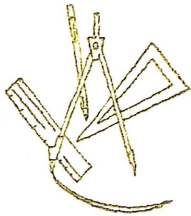

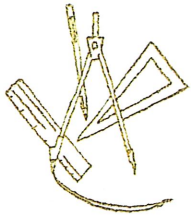


- **RGVMPO POLICY BOARD MEETING**
