### Overview

#### Amendment Overview

**For what purpose is an award amendment being requested? (Maximum allowable characters = 1500)**

Broken Arrow is requesting a shift in funds from Other Direct Costs, Indirect Costs and travel into Client Services. The remaining funds of \$15,442 will go into client services to assist more veterans who are in need of financial assistance.
