It was great to meet with both of you to discuss the Work Experience (WX) / Summer Earn and Learn (SEAL) programs. These two programs give program participants that lack work experience the opportunity to obtain experience at a job site in an entry level occupation for 3 to 6 months for WX and 5 weeks for SEAL. Once this training period is over, the program participants exit with the program with work experience better marketing themselves for future job search.
