I am requesting Permission to submit an application for a Mental Health Grant from the Texas Indigent Defense Commission. The purpose of the grant would be to hire an Attorney and a Social Worker to represent individuals in custody that are suffering from mental health issues. The Grant would fund either option: **(A)** 100% for two years with no matching funds required from the County or **(B)** 100% for the first two years with no matching funds from the County followed by a sliding scale for years 3-6: For ex. yr 3 (80%) State funding, yr 4 (60%) state funding, yr 5 (40%) state funding, yr 6 (20%) State funding and yr 7 (100%) funding from the County. Application deadline is **May 2, 2022**.
