**AMENDMENT TO CONTRACT FOR SERVICES BETWEEN
THE COUNTY OF HIDALGO
AND PLATINUM TRANSLATION, L.L.C.
#C-20-114-04-21**

This **AMENDMENT** to the **Contract** is made on this the 19th day of **April, 2022**, by and between the **County of Hidalgo, Texas** (the “County”) and **PLATINUM TRANSLATION, L.L.C. (Monica S. Rossler)** (the “Contractor”).

WHEREAS, County and Contractor entered into a Contract for Translation/Interpretation Services on or about April 21, 2020;

WHEREAS, the Agreement currently indicates that it will continue thru April 21, 2020, with the option to extend for two (2) one year terms under the same terms and conditions;

WHEREAS, it was intended for the Agreement to indicate a one (1) year term commencing on the effective date of the Contract (April 21, 2020) and continuing until April 20, 2021, with the option to extend for three (3) additional one (1) year terms under the same terms and conditions;

WHEREAS, the first of the three (3) additional one (1) year terms has been exercised and expires on April 20, 2022; and

WHEREAS, Parties desire to correct the error to the term and extension periods of the agreement and desire to amend the Contract as hereinafter provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Contractor hereby agree to the following amendment to the Contract:

1. Section “3.” of the Contract is hereby modified, amended, and or replaced as follows:

“3. Term. This Contract shall be for a period of **one (1) year(s)**, commencing on the effective date of this Contract and expiring on **April 20, 2021**, and may be extended at the sole discretion of the County for **three (3) additional one (1) year term(s)** under the same rates, terms and conditions unless this Contract is terminated pursuant to the provisions herein, whichever occurs first. Hidalgo County also reserves the right to continue this bid for an additional sixty (60) day grace period at the end of the contract term for unforeseen delay under the same rates, terms and conditions.”

2. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Contractor ratify and confirm the terms and provisions of the CONTRACT as amended herein.


