Good Afternoon Mr. Garcia,
This office reviewed Supplemental Agreement No. 2 to C-17-243-09-05 and at this time approves as to the form of the SA No. 2 subject to the following recommended modifications:

- 1. Add the following language in blue to the following section of SA No. 2:

NOW, THEREFORE, in consideration of the mutual covenants provided below, the **Owner** and the **Engineer** agree that **sections II and III of Supplemental Agreement No. 1 are superseded by the following and that said Work Authorization #7 is amended as follows:**

I. **Work Authorization #7** is revised to reflect the correct decreased project total cost from **\$315,000.00 to \$269,096.32; with a previously billed amount of \$82,901.43.**

II. Replace the fee proposal previously adopted by the Engineer and Owner in Supplemental No.1 to Work Authorization No.7, with the revised document **attached hereto and incorporated by reference into this Agreement as Exhibit D for all purposes.**

As discussed, please also inquire with the vendor to obtain a new Exhibit D to correct the reference to Supplemental Agreement No. 1 to Supplemental Agreement No. 2.
