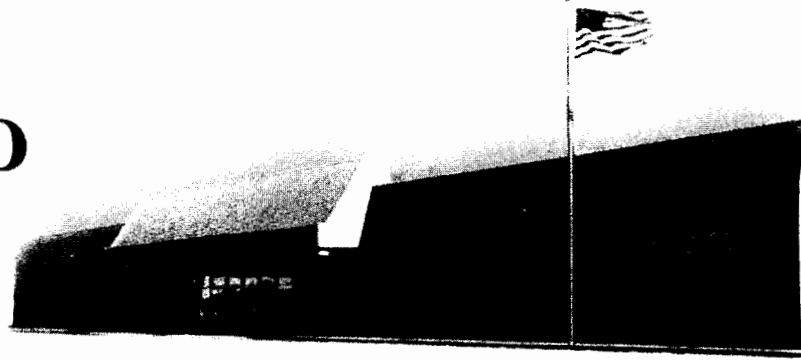

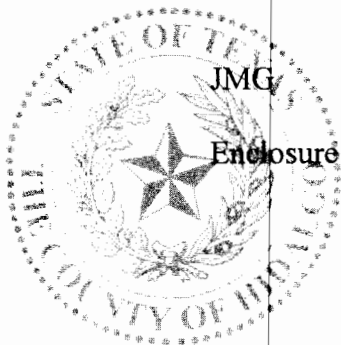
Gentlemen:

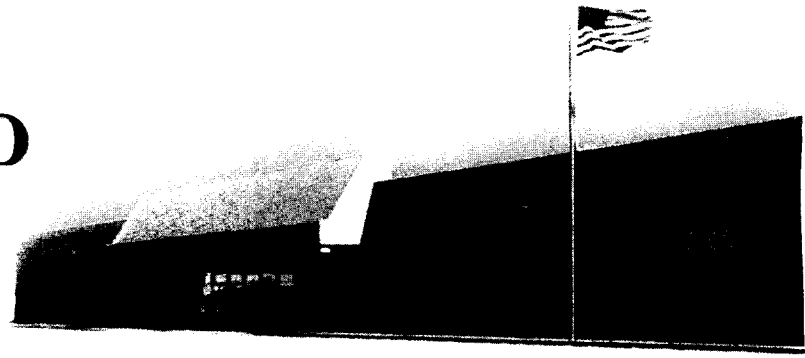

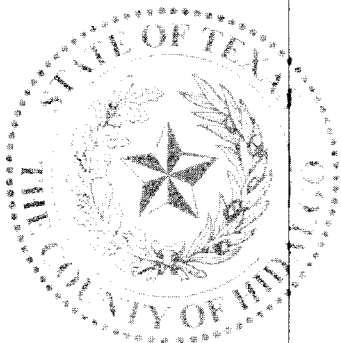
