Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for July 12, 2022. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 7.E. (AI-86369) – Public Defender (Membership Dues)

The affidavit for payment of membership dues is not attached to the agenda. We recommend that the affidavit be attached prior to Commissioners Court approval.

Consent Agenda Item 11.I.4 (AI-86470) – Purchasing Department for Health and Human Services

The certificate of insurance is not attached to the agenda. We recommend that the certificate of insurance be attached prior to Commissioners Court approval.

Regular Agenda Item 10.C (AI-86483) – Human Resources for Jail Commissary

The Personnel Adjustment Request Form (PAR) is not signed by the Department of Budget and Management. We recommend that the PAR form be signed prior to Commissioners Court approval.

Regular Agenda Item 10.D. (AI-86494) – Human Resources for Precinct 4

Pursuant to the Fiscal Note, funding for this request is undetermined. In addition, the Personnel Adjustment Request Form (PAR) is not signed by the Department of Budget and Management. We recommend that funding be identified and the PAR form be signed prior to Commissioners Court approval.

Regular Agenda Item 18.C.1. (AI-86424) – American Rescue Plan

The policy requires some additions/changes. We recommend that the policy be changed prior to Commissioners Court approval.

Regular Agenda Item 18.D.1. (AI-86414) – Budget Appropriations

The appropriation form is incorrect. We recommend that the form be corrected prior to Commissioners Court approval.

Regular Agenda Item 19.A.1. (AI-86419) – Purchasing for Emergency Management

ARPA funds will be used for this project. Therefore, the County is required to verify that OMNIA Cooperative followed the proper procurement process. In addition, the County must verify that the telecommunication equipment is not a prohibited purchase pursuant to 2CFR § 200.216. We recommend that the verifications be done prior to Commissioners court approval.

Regular Agenda Item 19.B.1. (AI-86497) - Purchasing for Precinct 1

The Certificate of Interested Parties (Form 1295) and certificate of insurance are not attached to the agenda. We recommend that the documents be attached prior to Commissioners Court approval.

Regular Agenda Item 19.C.1 (AI-86551) – Purchasing for Precinct 2

According to the agenda caption ARPA funds will be used to fund a portion of the project; however, the ARPA project has not been approved by Commissioners. We recommend that the ARPA project be approved prior to Commissioners Court approval.

Regular Agenda Item 19.C.2. (AI-86550) – Purchasing for Precinct 2

The Letter of Engagement and legal counsel's review and approval of the Letter of Engagement are not attached to the agenda item. We recommend that the documents be attached prior to Commissioners Court approval.


Regular Agenda Item 19.H.1. (AI-85964) – Purchasing for Elections Department

The agreement, legal counsel's review and approval of the agreement, and the certificate of insurance are not attached to the agenda item. In addition, the funding information was not provided. We recommend that the documents be attached and funding information be listed in the fiscal impact section of the agenda item prior to Commissioners Court approval.

Regular Agenda Item 19.I.1. (AI-86241) – Purchasing for Tax Office

The Purchasing Department is requesting approval of a "Sole Source Declaration" for a tax collection system; however, a tax collection system can be obtained from multiple sources. Therefore, we recommend that competitive bids or competitive proposals be obtained for a tax collection system. Alternatively, legal counsel's opinion should be requested to determine whether a "Sole Source Declaration" for the procurement of the tax collection system is proper.
