Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for July 26, 2022. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 12.B. (AI-86640) – Membership Dues/Certifications CCL 4

The affidavit for payment of membership dues is not attached to the agenda. We recommend that the affidavit be attached prior to Commissioners Court approval.

Regular Agenda Item 12.B. (AI-86720) – Health and Human Services Department

According to the Health Department, no action will be taken on this agenda item. The agreement and legal counsel's review and approval of the agreement are not attached to the agenda item. We recommend that the documents be attached prior to Commissioners Court approval.

Regular Agenda Item 12.G. (AI-86703) – Health Care Funding District

The request to certify revenues was not sent to the Auditor's Office. In addition, the appropriation form is not attached to the agenda. We recommend that the request be sent to the Auditor's Office for approval and the appropriation form be attached to the agenda item prior to Commissioners Court approval.

Regular Agenda Item 22.F.3. (AI-86716) – American Rescue Plan Act

An email was sent with a concern related to the evidence-based documentation. We recommend that the concern be addressed prior to Commissioners Court approval.

Regular Agenda Item 22.F.4. (AI-86719) – American Rescue Plan Act

An email was sent regarding the ARPA expenditure category used to support the purchase of vehicles and equipment. The purchase of vehicles and equipment may be an ineligible cost. We recommend that no action be taken on this agenda item until additional analysis on the eligibility of the proposed purchase can be done.

An email was sent with concerns related to this agenda item. Some of the concerns have not been addressed. We recommend that the concerns be addressed prior to Commissioners Court approval.

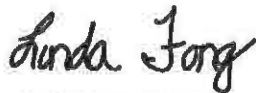
Regular Agenda Item 23.H.2. (AI-86644) – Purchasing Department for Facilities Management
