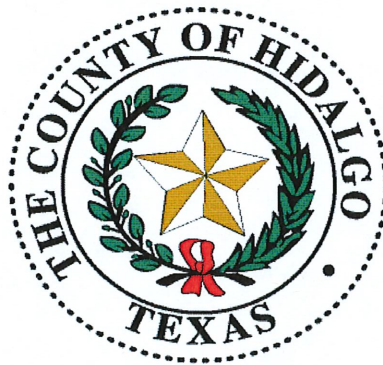

Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for August 18, 2022. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 7.A. (AI-86956) – County Clerk

There are insufficient funds in the account to pay for membership dues. We recommend that funding be in place prior to Commissioners Court approval.

Consent Agenda Item 9.B. (AI-87074) – County Judge's Office Emergency Management

The amount (\$15,500.00) on the agenda caption is incorrect. We recommend that the correct amount be read for the record.

Consent Agenda Item 10.D. (AI-87026) – Purchasing Department for Executive Office

An email was sent with a list of documents needed prior to processing a payment. We recommend that the documents be provided to the Auditor's Office in order to process the payment.

Regular Agenda Item 16.B. (AI-87045) – Human Resources for WIC

The fiscal note is not attached to the agenda. We recommend that the fiscal note be attached prior to Commissioners Court approval.

Regular Agenda Item 16.C. (AI-87047) – Human Resources for Urban County

The fiscal note is not attached to the agenda. We recommend that the fiscal note be attached prior to Commissioners Court approval.

Regular Agenda Item 16.D. (AI-87062) – Human Resources for DA's Office

The Personnel Adjustment Request Form (PAR) and Fiscal Note are not attached to the agenda. We recommend that the documents be attached prior to Commissioners Court approval.

Regular Agenda Item 23.B.2. (AI-87056) – Commissioner Precinct 3

Commissioners Court written approval pursuant to Texas Government Code §791.014 is only required for projects to construct, improve, or repair a building or other facility. This agenda item is related to a Wi-Fi project; therefore, we recommend that no action be taken on item 23.B.2.

Regular Agenda Item 23.C.2. (AI-87024) – Commissioner Precinct 3

Commissioners Court written approval pursuant to Texas Government Code §791.014 is only required for projects to construct, improve, or repair a building or other facility. This agenda item is related to a Wi-Fi project; therefore, we recommend that no action be taken on item 23.C.2.

Regular Agenda Item 24.A. (AI-86928) – Commissioner Precinct 4

The insurance certificate is not attached to the agenda. We recommend that the insurance certificate be attached prior to Commissioners Court approval.

Regular Agenda Item 25.D.1. (AI-87076) – American Rescue Plan Act

The project description, agenda briefing, agreement, and legal counsel's review and approval of the agreement are not attached to the agenda. In addition, the fiscal impact is not referenced in the "fiscal impact" section of the agenda; therefore, we were not able to determine if funding is in place. We recommend that the documents be attached and the fiscal impact be referenced prior to Commissioners Court approval.

Regular Agenda Item 26.B.1. (AI-87035) – Purchasing Department

The written findings, legal counsel's review and approval of the findings, and the Certificate of Interested Parties (Form 1295) are not attached to the agenda. In addition, the certificate of insurance does not list Hidalgo County as the certificate holder. According to the Purchasing Department, no action will be requested on this agenda item.


Regular Agenda Item 26.J.1. (AI-87023) – Purchasing Department
