Thank you for your interest in Operation Lockdown.

Attached you will find all supporting documentation on Operation Lockdown, to include a data sharing agreement (DSA/MOU).

First step to joining Operation Lockdown is to get that DSA/MOU signed. I will then forward to DEA Chief of Intelligence for approval and signature. Once we get the DSA/MOU signed by both parties, I will then forward instructions to follow to begin data sharing, which will create de-conflictions with inmates calls and active investigations in the field (Federal, State and Local).
