I am writing to provide information related to the development of the SEX Trafficking (SXTR) Protocols in Hidalgo County and the upcoming Re-Execution of the Memorandum of Understanding and Working Protocols with the Children's Advocacy Center of Hidalgo and Starr Counties which. Both documents need to be executed by September 1, 2022.

Sex Trafficking Protocols/Guidelines

Over the last eight months, the CAC, the District Attorney's Office, MDT Partners, and community agencies have been meeting with the Office of the Governor. During these meetings, the Sex Trafficking Protocols for Hidalgo County were developed to coordinate the response to assist Sex Trafficking victims. These protocols need to be reviewed (attached) and signed by all agencies that will be handling sex trafficking cases in Hidalgo County. Please respond with any changes no later than July 31, 2022.
