Upon arriving from the East Hidalgo Detention Center, Inmate ~~XXXXXXXXXX~~ check for \$301.88 was lost by the Hidalgo County Adult Detention Center. East Hidalgo Detention Center reissued the check to the inmate but at a cost of \$35.99. Therefore, the new check was for \$265.89 rather than \$301.88. Given that the Hidalgo County Adult Detention Center is at fault of the lost check, the Jail owes this inmate the difference of \$35.99.
