**FOURTH AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT
BETWEEN COUNTY OF HIDALGO, TEXAS AND
TEXAS A&M UNIVERSITY-KINGSVILLE**

This Amendment to the Interlocal Agreement is made this _____ day of _____, 2022, by and between **COUNTY OF HIDALGO, TEXAS**, hereinafter referred to as “County”, by and through the Hidalgo County Constable Precinct No.1 and No.3 (collectively, the “HCCO”), and **TEXAS A&M UNIVERSITY-KINGSVILLE**, herein after referred to as “TAMUK”, by and through the TEXAS A&M UNIVERSITY-KINGSVILLE POLICE DEPARTMENT.

WHEREAS, TAMUK and County entered into an Interlocal Agreement to enhance the parties’ ability to effectively address alleged crimes; which includes sharing information about Texas A&M University Kingsville, Citrus Center Campus, students and employees who are the victim of, a witness to, or an alleged perpetrator of an offense of violence or sex offense;

WHEREAS, the Agreement commenced on September 3, 2019;

WHEREAS, on August 24, 2021, January 19, 2021, and December 14, 2021 the Agreement was extended and modified to clarify the compensation terms related to reimbursing the County for costs associated with providing services; and

WHEREAS, the Parties now wish to extend the Agreement for an additional year and modify the Agreement by incorporating a revised **Exhibit “A”** and clarifying the compensation terms related to reimbursing the County for costs associated with providing services during Fiscal Year 2022 from 9.27.2022 to 9.26.2023.

NOW, THEREFORE, and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TAMUK and County hereby agree to the following:

1. The second paragraph in Section "15." of the Agreement is hereby modified and replaced as follows:

"TAMUK agrees to pay and reimburse HCCO for actual costs borne by Hidalgo County pursuant to this Agreement, a total annual compensation amount of thirty thousand fifty dollars and zero cents (\$30,050.00) for both Constable Pct. 1 & Pct. 3, as further described in **Exhibit "A"** attached hereto, incorporated, and made part of this Agreement. HCCO will not exceed the amount of monthly overtime hours of fifty (50) hours a month. HCCO will submit monthly invoices to TAMUK for the actual costs to be reimbursed to HCCO. TAMUK agrees to pay promptly upon receipt of said invoices."

2. Except as modified herein, all other terms and conditions of the Agreement, remain in full force and effect. County and TAMUK ratify and confirm the terms and provisions of the Agreement as amended herein.
