Ms. Jaclyn,

Good afternoon. We would appreciate your input and assistance in modifying the current agreement between STC and County.

Can you please insert the proper language to ensure a solid modified agreement? I have the following as a guide as to what we are trying to accomplish.

We would like to propose making some modifications to the above agreement. The first change benefits STC and since Section 11.3 of the current interlocal contract allows for changes, pending consensus, we would like to proceed with something like the following modifications.

First, by moving the date from March 31, 2024 to December 2024, (Section 3.1 paragraph 4, of the current accord) the college will have more time to expend the ARPA funds and show evidence for expenditures.

Secondly, we would like to expand Section 3.7 (its own paragraph of the current agreement) by inserting the following:

“Such copies of ‘reimbursables’ will be provided to County before each installment. In addition, in order to qualify for the second disbursement, all supporting documentation regarding the first pay of \$500,000.00 must be submitted BEFORE the second installment of December 2022.”

Upon further review, we have determined that documentation is of essence for compliance with any past, current and future distribution of State and Local Fiscal Recovery Funds (SLFRF).
