**ORDER SETTING SALARY OF COUNTY AUDITOR,  
ASSISTANT AUDITORS AND BUDGET OF THE COUNTY AUDITOR**

PURSUANT TO AND IN ACCORDANCE WITH Section 152.905 of the Local Government Code, at 11:30 a.m. on the 15<sup>th</sup> day of November 2022, a PUBLIC HEARING was held by videoconference (Zoom) on the matter of setting the salary of the County Auditor and Assistant County Auditors.

IT WAS VOTED THAT the salary of the County Auditor and Assistant Auditors be set effective January 1, 2023, as per Exhibit "A". Furthermore, because it is necessary to employ and appoint suitable individuals to perform the work required of the County Auditor's Office, the County Auditor is hereby given the authority to: (a) continue the employment of the persons appointed, discharge said persons if warranted, and accept resignations; and (b) promote, demote, and transfer persons to other slots and adjust salaries accordingly taking into consideration increased or lessened responsibilities, added experience or education, the volume of work handled, and the length of service.

Also, the Budget of the County Auditor's Office was approved as submitted, as per Exhibit "B". The County Auditor may amend the budget listed in Exhibit "B" to transfer an amount budgeted for one item to another budgeted item.

THEREFORE, it is the Order of the District Courts of Hidalgo County, that the aforementioned salaries and budget be set, and it is Hereby set as of January 1, 2023.

IT IS FURTHER ORDERED that this Order be spread on the Minutes of each of the District Courts of Hidalgo County, Texas, and the District Clerk of Hidalgo County, Texas furnish the Commissioner's Court of Hidalgo County, Texas a certified copy of this Order.
