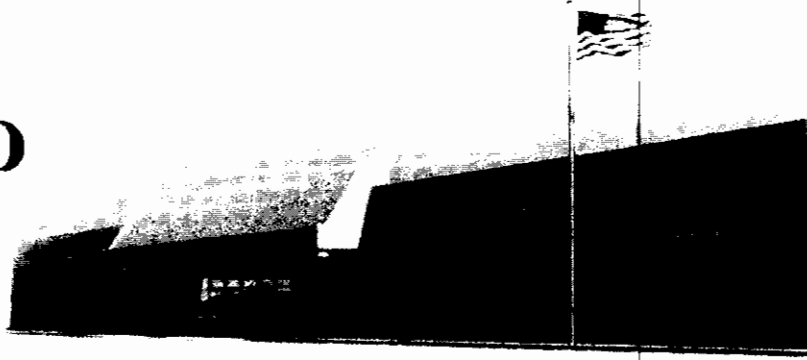

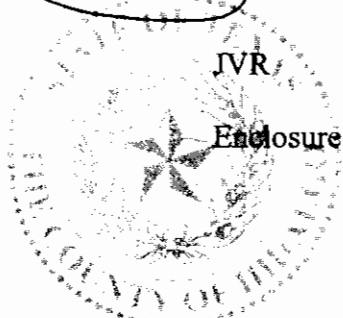
Gentlemen:
