10.02 Bid Bond. In accordance with Tex. Loc. Govt. Code sec. 262.032, If a contract is for the construction of public works or is a contract exceeding One Hundred Thousand Dollars (\$100,000.00), the bid specifications or request for proposals may require the bidder to furnish a
