**FIRST AMENDMENT TO  
INMATE COMMUNICATIONS AGREEMENT  
(C-21-134-11-30)**

This **FIRST AMENDMENT to Inmate Communications Agreement** (“Agreement”) is made **this \_\_\_ day of \_\_\_\_\_, 2023**, by and between the **COUNTY OF HIDALGO, TEXAS** hereinafter referred to as the (“County”) and **NCIC Inmate Communications, Inc.**, hereinafter referred to as the (“Vendor”).

**WHEREAS**, on or about December 3<sup>rd</sup>, 2021, the County entered into an Inmate Communications Service Subscriber Agreement, with Vendor, in which Vendor agreed to provide inmate telephones and related communication services to County; and

**WHEREAS**, the parties desire to amend the Agreement, to provide clarification as to the purchase of inmate phone cards; and

**WHEREAS**, Vendor has included these services as part of the Agreement with County to include specific rate and discount information related to the purchase of the inmate phone cards; and

**WHEREAS**, the Parties now desire to amend the Agreement as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Vendor hereby agree that said Agreement is amended as follows:

Attachment A (Calling Rates, Fees, and Commissions) to the Agreement, is clarified to include the following inmate phone card price and discount information provided by the Vendor:

- 1. Vendor**, shall provide County with Inmate Phone Cards at the sale price of \$10.00 per unit.
- 2. Vendor**, shall provide County with a 70% discount for the total price of Inmate Phone Cards invoiced monthly to the Hidalgo County Sheriff’s Office.

3. **Vendor**, shall notify County of any increase, decrease, or modification to the rates, fees, and commissions set forth in Attachment A and this First Amendment.
4. **Vendor**, shall provide any and all documentation to justify any increase, decrease, or modification to the rates, fees, and commissions set forth in Attachment A and this First Amendment.
5. Except as modified herein, all other terms and conditions of the Agreement, as amended by this First Amendment, remain in full force and effect and Vendor and County ratify and confirm the terms and provisions of the Agreement as amended.
