Good Afternoon Ms. Vela,

As discussed, it is recommended to make the following modifications to the MOU between WIC and Mission Hospital:

1. Replace sec. II with the following:

The term of this Agreement shall be for a period of one (1) calendar year from the date of execution by both parties. This Agreement shall automatically renew annually for successive one (1) year periods unless it is terminated as provided below.

2. Replace section III with the following:

This Agreement may be terminated by either party at any time, with or without cause, by providing at least thirty (30) days written notice to the other party hereto of the intention to terminate, or it may be terminated immediately by mutual written agreement of the Parties. This Agreement may be amended or modified by written mutual agreement of the parties.

3. Revise section VI Notices as discussed, including but not limited to - replacing specific names with titles in Attn: sections, correcting office name, spelling:

4. Replace section VIII Indemnification with the following:

**SERVICE PROVIDER shall indemnify and hold harmless County, its elected officials, employees and agents from any and all claims, damages, losses, and expenses including attorney's fees for the defense of any action against County arising out of, resulting from, or connected with the provision of the Service under this Contract. Said indemnity shall cover any act or failure to act by the SERVICE PROVIDER, its agents or employees.**
