Award Description

This award funds the approved 2023-24 SCP program. Your 2023-24 statutory match is 7% and your budgetary match is 7.9%. This award adds permanent funding to increase the stipend amount by \$11,618 to align with the FY 22 congressional stipend increase. This award adds permanent funding increase to the baseline funding amount by \$174,178 to ensure no volunteers are displaced by the \$4 increase. This award also extends the 2023-24 program year by three months for the purpose of aligning the award with stipend program start dates. The 2024-25 program year grant will have a July 1 start date.
