Consent Agenda Item 4.A. (AI-90408) – 2022 Interdepartmental Transfers  
No action will be requested on this agenda item.

Consent Agenda Item 8.A. (AI-90535) – Executive Office  
The insurance certificate from Jubilee 4 Nutrition has not been received. We recommend that the insurance be provided by Jubilee 4 Nutrition prior to Commissioners Court approval.

Consent Agenda Item 10.A. (AI-90470) – Tax Office  
The agenda caption states the wrong tax account number for no. 5 (Spec’s Liquor Stores). The correct tax account number is S3280.99.000.0001.08. We recommend that the correct tax account number be read for the record.

Consent Agenda Item 15.A.2. (AI-90200) – Purchasing Department  
The vendor did not agree to the 60-day extension due to price increases. We recommend that no action be taken on this item.
