On October 13, 2020 at 09:33 a.m., I Officer Victor Duberney #143 was dispatched to the Hidalgo County Health & Human Services in reference to a theft.

Upon arrival, I made contact with reporting party, Director Rigoberto Hinojosa (06/30/1969) who properly identified himself with TX DL#13518138. Rigoberto stated that upon checking last years inventory it was noticed that there was a few items missing. As their policy there has to be an attempt to recover or to find the missing items before the items get entered as stolen. Rigoberto stated that a whole year has past by and still no signs of the missing items. He had attempted to find the missing items to the best of his ability, but he has not recover none of the items. I asked Rigoberto if he there was records of all the equipment that gets issued out to the employees. He stated that he does keeps track of all the items, but there was some information missing. Rigoberto stated that June 2019 he was out of town where he was advised that some items would be checked out for an event. Rigoberto's inventory was not updated, so the missing items where never assigned to anybody. Rigoberto was advised that the checked out equipment was properly tagged, but still not logged into records. Rigoberto stated that he just needs to placed the missing items as stolen as they are governmental equipment. Macon Portable Radio (black), P7170, 806-870 hhz (valued at \$3,662.80 USD), 2 HP SB 850 laptops (black) (valued both at \$1,599.97 USD), black Brady BB31 Sign & Label Printer (\$2,070.60 USD), and 3 Microsoft Surface Pro 12.3 - Core I5 7300U (all valued to \$3,749.97 USD). The total amount of all the missing items is \$11,082.74 USD. Rigoberto stated that the department would like to file formal charges to whomever is responsible for the theft of equipment. Rigoberto was given a case number and proper complaint procedures.

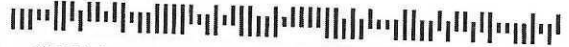
