Corporate Account Credit Agreement, Terms & Conditions

1. These terms and conditions apply to purchases made on your Hammacher Schlemmer Corporate Account. Use of such account constitutes acceptance of Hammacher Schlemmer's terms and conditions in effect at the time of purchase.
2. All orders must be accompanied by a purchase order and are subject to availability.
3. Hammacher Schlemmer must receive payment in full within thirty (30) days of invoice date. If payment is more than fifteen (15) days past due, the discount will be lost, and the customer agrees to pay the full retail price as well as a finance charge of one and one-half percent (1.5%) per month.
4. Corporate accounts may be established by application to Hammacher Schlemmer in writing. Customer's employees designated in such application are authorized by customer to make purchases on behalf of customer and to authorize purchase by their employees. Hammacher Schlemmer shall be entitled to rely upon such authority until advised otherwise in writing by customer.
5. Merchandise designed, etched or engraved to customer's order or bearing customer's logo or name is not returnable unless it does not conform to agreed upon specifications. Excessive or habitual returns may subject account to closing.
6. All Corporate Merchandise Certificates are non-returnable.
7. Volume purchase returns are subject to a 15% restocking fee.
8. Defective merchandise should be returned within 45 days of receipt of product.
9. Customer agrees to pay for all authorized purchases on its account by cash or business check. In the event that it is necessary to place this account in the hands of an attorney or collection agency, the customer agrees to pay the costs of collection including reasonable attorney fees and court costs.
10. Hammacher Schlemmer reserves the right to limit credit, close accounts or change these terms and conditions from time to time and agrees to notify the customer of these changes. Failure to enforce any provision of these terms and conditions shall not prejudice the right of enforcement at some future time.
11. Packing and shipment charges will be quoted, if applicable, in the written confirmation of the order.
12. Hammacher Schlemmer reserves the right to limit the quantity of merchandise sold to any Customer.
13. Applicant authorizes Hammacher Schlemmer to perform complete credit check with TRW and like agencies on applicant's company; or if appropriate, on individuals owning applicant's company.
