On Wednesday, April 5, 2023 at 11:43am, I Officer R. Molina 91, responded to the Hidalgo County Precint 4 Office located at 1124 N. M Rd. in reference to an information report.

Upon arrival, contact was made with Jose Segovia who is an employee at location. Jose stated there was a large 30 yard roll off container which contained several industrial items (toolboxes, high wheel cyclers, compressors, fuel tank units, diesel tank units, truck racks, etc.) there at location. Jose said they were no longer using the items in the container and they were supposed to be taken to a surplus auction in Edinburg, Tx. Jose stated an employee accidently took bin along with all of its industrial contents to a recycling center in Mcallen, Tx. Jose stated the employee believed he was supposed to the items to the recycling center instead of the auctioning site. Jose stated he needed to document this incident that way he could mark off all the items listed above from his inventory. He was provided with a case number and told an information report would be filed.
