This office has reviewed Landstar Telecom Quote #OR24402 and makes the following recommendations:

5.1 Term; Other Agreements - changes below in red

The initial term shall be as provided in the SOF (the "Initial Term"). Alternatively, the SOF may specify that the Agreement is conterminous with another Agreement for Services entered into between Landstar Telecom and Customer, in which event the agreement shall have the same Initial Term as is provided in such other Agreement. After the Initial Term, all Services under the Agreement shall renew on an annual basis, **subject to the same rates and Standard Terms and Conditions of Service, unless either Party terminates the Agreement, at any time, without cause upon sixty (60) days written notice.**

9.4 Arbitration - replace with:

9.4 Dispute Resolution. In the event that a dispute arises out of this Agreement between the Parties, Parties may agree to utilize mediation as a method of alternative dispute resolution (ADR). Nothing in this Agreement is intended to and County does not hereby waive, release or relinquish any defense or immunity available to it by virtue of state or federal law, rule or regulation.
