We have this 10 year agreement with a 10 year renewal that we have been working on, it was approved on 9/11/2013 (AI 40511) with the option of renegotiating fees every 2 years.

On 9/29/2015 there was modification to the contract where they changed the fees from \$3,000.00 a month to \$5,000.00 a month for rent (AI 51373).

On 11/18/2022 there was an Amendment made for the FY 2022-2023 lowering down the renth fees to \$3000.00 (AI 88106), my question is, do we need to have another amendment or what would be the correct procedure?
