**FIRST AMENDMENT TO
SERVICE AGREEMENT
(C-22-0469-08-18)**

This **AMENDMENT** to Requirements Agreement (“Agreement”) for “**Xerox Copier Lease Agreement – Sheriff’s Office**” is made this **5th** day of **September, 2023**, by and between the **COUNTY OF HIDALGO, TEXAS** hereinafter referred to as (“County”) and **Xerox Financial Services**, hereinafter referred to as the (“Vendor”).

WHEREAS, on August 18, 2022, County entered into a Service Agreement, with Xerox Financial Services, (“Vendor”), in which Vendor agreed to provide a service to Hidalgo County, Xerox Copier Lease Agreement, as described in the contract;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Vendor hereby agree that said Agreement is amended as follows:

1. **The County of Hidalgo** shall arrange with the supplier the removal of one (1) of the seven (7) equipment labeled Xerox AltaLink B8155 55 PPM-Network Printer, Copier, Email, and Office Finisher (EQ372483) from location “Releasing Dept.” at the Hidalgo County- Sheriff’s Office (Jail Building).
2. Equipment returned to Xerox Financial Services, LLC shall be in the same condition as when delivered, except for “ordinary wear and tear.”
3. It is solely the responsibility of Hidalgo County to secure any sensitive data and permanently delete such data from the internal media storage prior to returning the equipment to Xerox Financial Services, LLC.

4. Supplier removed monthly equipment fee of \$141.25 and monthly service fee of \$34.25 for the removal of Xerox AltaLink B8155 55 PPM- Network Printer, Copier, Email, and Office Finisher (EQ372483) located in "Releasing Dept." at the Hidalgo County- Sheriff's Office (Jail Building) resulting in a new monthly lease amount of \$1,911.24 for the remaining copiers.
5. Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and Vendor and County ratify and confirm the terms and provisions of the Agreement as amended.
