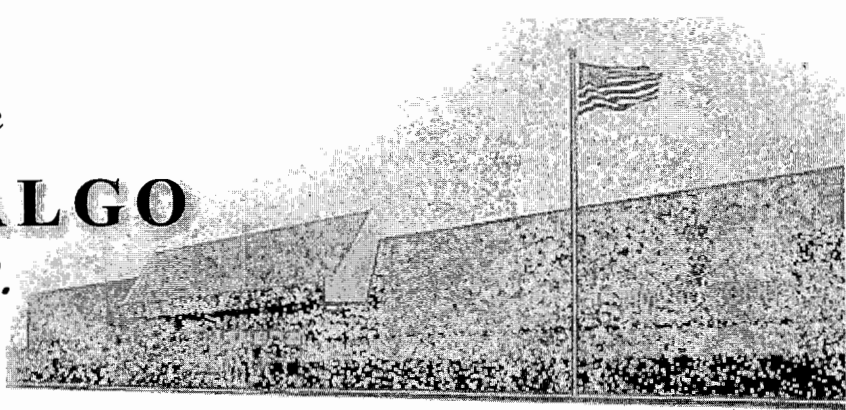



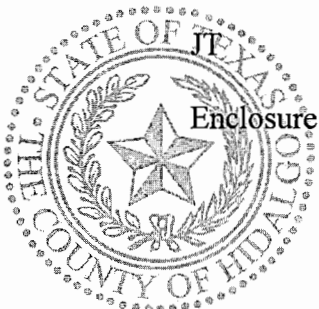
Commissioners Court:
