My name is Maryann Denner and I am Director and Chief Probation Officer at the Hidalgo County Juvenile Probation.

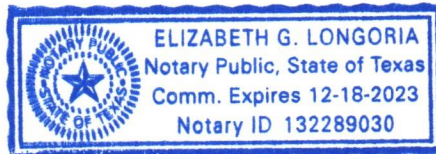
