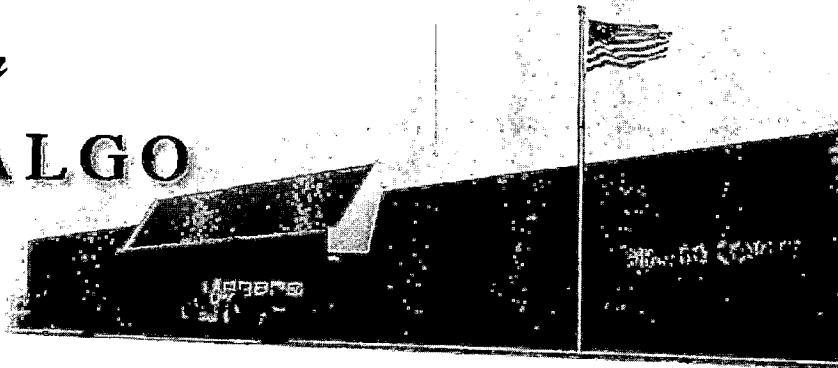

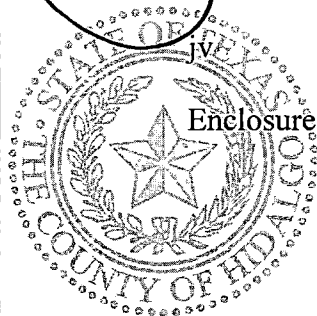
Commissioners Court:

When completed, please return the attached to our office. Thank you for your assistance in this matter.

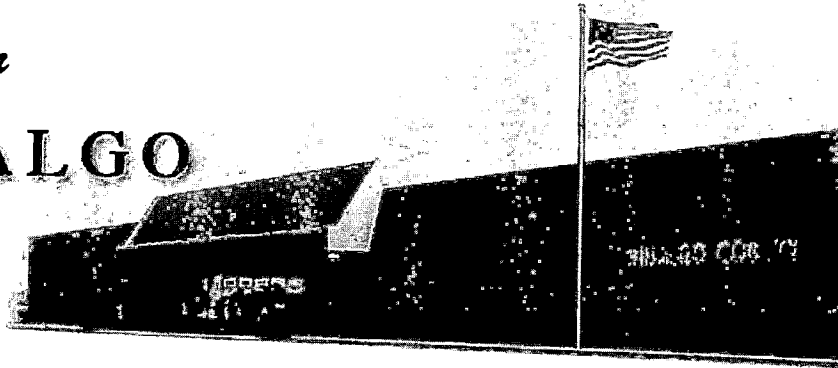
